OPS Command has been provided with POU commanders (OPP & YRP), major critical incident commanders (OPP & YRP), a OPP Provincial Liaison Team (PLT) commander and an OPP Forensic Psychologist to ensure they have access to technical/tactical support and subject matter counsel to advance their concepts of operations and planning process.

To assist in negotiating a peaceful resolution, PLT will be engaging with demonstrators and identified leaders throughout the weekend.

OPP Forensic Psychologist is assisting with developing a negotiation plan to supplement PLT and target entities who are less likely to respond favourably to PLT.

Priority locations have been identified for strategic enforcement opportunities, and the enforcement planning process is running parallel to the efforts of PLT and plans to initiate a negotiation strategy.

- Ongoing speeches appear to be impromptu.
- Narrative is not aggressive or violent.
- Approx 4,200 demonstrators remain in the area.
- Counter protests continue.
- Crowd mood described as festive, no issues to report.
- OPS PLT advised that the wooden structure has been pushed under a bridge, completely blocking access to roadways.
- Organizers advised [REDACTED] that they will ensure emergency routes will remain open, and there will be attempts to remove the wooden structure.
- Organizers have advised [REDACTED] that they are seeking portable toilets.
- Organizers indicate that they are unhappy with how they are being portrayed in the media.
- Organizers describe that they are committed to keeping interactions with police positive.
- PPS observed fireworks being set off on Parliament Hill, which is a concern due to fuel canisters in the protest zone.
- PPS has observed a significant amount of open alcohol being consumed within the protest zone.
- OPP POU conducting rotating patrols downtown Ottawa with Durham Regional PS in soft tac. No issues to report. Expected to remain on ground until 2400 hrs tonight.

Toronto:

- Earlier, there were as many as 4K people in the area of Queens Park. With the exception of a male who was arrested for assault with a weapon, administering a noxious substance (smoke bomb) and public mischief, the crowd was positive and included a fair number of families and kids.
- Protesters got in a heated verbal confrontation with counter-protesters on University Avenue south of Queen's Park.
- Small-group of counter-protestors gathered in front of MaRS building near Queen's park subway station.
- Some officers experienced difficult reporting for work due to traffic congestion.
- As of 6 pm, the following road closures were in place: Don Valley Pkwy South at Richmond St; Gardiner XWY E/B at Lake Shore Blvd; Avenue Rd is closed from Bloor St West to Davenport Rd; and, Dundas St is closed from Spadina Av to Yonge St.
- TPS will be maintaining its operational posture (protecting critical infrastructure) again tomorrow, and OPP will continue providing the same level of support.

Ottawa:

- OPS have commenced with arrests (2) for parties supplying/transporting fuel.
- Stage on Wellington Street remains in place.
- POU (Non-OPP) in soft tac working on a one hour cycle.
- Approximately 1,000 participants remain on site.
- Majority of trucks that arrived on 05Feb2022 have left the area.
- OPS members were issuing tickets and were confronted by a verbally aggressive group. These individuals dispersed once tickets were handed out.
- Majority of the crowd remains cooperative.
- OPS announced on social media that they will begin to conduct enforcement activities.
- 95 on-duty OPP officers deployed.

Toronto:

- Approximately 100 people reported at North Park, no issues to report.
- OPP members deployed to 20 static traffic locations to assist TPS.
- Discussions with TPS regarding demobilization of resources.
- CP will remain operational until officers clear from Toronto detail tonight.
- CP will resume operations on 07Feb2022 at 0800hrs.

Provincial:

- Highway 402 WB remains closed at Highway 40.
- Approximately 25 vehicles remain parked on Highway 402 at Front Street, resulting in two lanes being blocked.
- Some occupants of the vehicles have departed, leaving their vehicles behind.
- Approximately 6 protestors remain on the Highway with their vehicles.
- WB commercial traffic continues to stage at local truck stops, waiting for the highway to reopen.

Ottawa:

- RCMP and OPP Command met with OPS Interim Chief Steve Bell and A/Deputy Chief Ferguson. Chief Bell accepted the offer from the OPP and RCMP to establish a unified command team (OPS Chief, OPP D/Commissioner and RCMP D/Commissioner) to oversee the operations in Ottawa. They will provide strategic direction to the operational commanders and subject matter experts executing the operational plan. Purposefully selected from within the RCMP, OPP, TPS, YRP, WRP & PRP, the integrated team includes a forensic psychologist, who specializes in crowd dynamics; critical incident commanders; public order commanders; and, experts in planning, logistics and the use of liaison officers in negotiations. Operating in parallel, is a joint forces multi-jurisdictional criminal investigation.

- PLT is focused on voluntarily exiting demonstrators to reduce the footprint in Ottawa. The new Critical Infrastructure and Highways regulation, along with the declaration of Exclusion Zones under the Emergency Act, will assist PLT and be relied upon for enforcement.

- The strategic priorities are to prevent the attendance of further convoys/blockades; noticeably reduce the footprint currently occupied by demonstrators, ultimately leading to the clearing of all blockades, and the securing of critical infrastructure, including roadways and highways.

- The strategic priorities will be accomplished under the direction of the critical incident commanders, who apply the theory of Necessary / Risk Effective / Acceptable to their critical operational decision making to prioritize safety.
