Dear Mr. Sheppard:

On behalf of our client GoFundMe, Inc. ("GoFundMe"), I write in response to your July 15, 2022 Letter pertaining to GoFundMe's removal of the Freedom Convoy fundraiser from its platform due to its violation of GoFundMe's Terms of Service and GoFundMe's subsequent initiation of full refunds, including any tips and transaction fees, for all donations made by all donors. We believe that the following summary of the Freedom Convoy fundraiser and GoFundMe's actions with regard to it, along with the key documents accompanying this letter, will fulfill the needs of your investigation as it pertains to GoFundMe. If you have any additional questions after you have had the chance to review this information, please do not hesitate to contact me.

GoFundMe provides this response voluntarily, while preserving all rights and objections. This response is based on GoFundMe's understanding of the information reasonably available to it as of the date of this letter. This response and the accompanying documents contain confidential business information and are being provided for the sole purpose of resolving questions raised by Public Order Emergency Commission about the Freedom Convoy fundraiser and GoFundMe's decision to remove it from its platform. GoFundMe requests that the information herein be used only for this purpose and not be shared with or disclosed to any other party. GoFundMe reserves the right to supplement or amend this response should further investigation of this matter so require.

I. GoFundMe's decision to remove the Freedom Convoy fundraiser from its platform

a. GoFundMe coordinated with the Freedom Convoy fundraiser organizer to ensure contributions would be used to carry out the stated purpose set forth in the fundraiser and comply with GoFundMe's Terms of Service.

The Freedom Convoy fundraiser was created on the GoFundMe platform on January 14, 2022. The fundraiser organizer, like all GoFundMe fundraiser organizers, agreed to abide by GoFundMe's Terms of Service as a condition of posting the fundraiser to the platform. Based on the original fundraiser description, GoFundMe understood that the organizer's goal was to support a peaceful demonstration in Ottawa protesting certain rules and mandates issued by the Canadian government. On January 22, 2022, the organizer edited the fundraiser to include the following language: "Any left over donations will be donated to a credible Veterans organization which will be chosen by the donors."

On January 27, 2022, the organizer agreed to and signed the GoFundMe Letter of Attestation. Per the terms of the Letter of Attestation, the organizer agreed that any distributed funds would be "held by [the fundraiser organizer] as a fiduciary for the ultimate benefit of the Convoy Participants and any charitable organizations chosen to receive any remaining funds." The organizer also agreed that she would be responsible for delivering the funds in a manner consistent with the plan laid out in the Letter of Attestation and the purpose of the fundraiser. The organizer likewise confirmed that both the use of funds and her use of the GoFundMe platform were subject to the Terms of Service. Finally, the Letter of Attestation specified that "[a]ll funds not distributed to Convoy Participants will be delivered to yet-to-be-determined registered charitable organizations in good standing."

Upon receiving the executed Letter of Attestation from the organizer, on January 27, 2022, GoFundMe initiated through Stripe (the third-party payment processor) a single distribution of \$1M CAD comprised of Freedom Convoy fundraiser donations, which was deposited to the bank account designated by the organizer. This was the only distribution made from the fundraiser.

## b. GoFundMe monitored and ultimately removed the Freedom Convoy fundraiser from its platform in accordance with the Terms of Service.

On February 2, 2022, after several days of reviewing publicly available reports by local authorities, including a statement issued by the Ottawa Police describing the Freedom Convoy demonstration as "unique in nature, massive in scale, polarizing in context and dangerous in literally every other aspect of the event itself," GoFundMe suspended the fundraiser for review. While suspended for review, donations and withdrawals were both paused.

From February 2, 2022, to February 4, 2022, GoFundMe continued to monitor the demonstration. On February 2, 2022, during a press conference held by the Ottawa Police, Deputy Chief Steve Bell called the demonstration something "between a demonstration and a long-term plan to occupy [Ottawa] streets" and described the demonstrators remaining in Ottawa as "a highly-determined and highly-dedicated group of unlawful individuals." <sup>10</sup>

GoFundMe then spoke directly with Deputy Chief Bell shortly after his remarks to the press. Deputy Chief Bell reiterated his description of the demonstration as an "occupation" and confirmed that there were several active investigations into acts of violence or hate perpetrated by demonstrators. Deputy Chief Bell also noted that Freedom Convoy protestors were discussing how the funds raised by the GoFundMe Freedom Convoy fundraiser would allow them to extend their presence in Ottawa.

On February 3, 2022, GoFundMe spoke with Ottawa Mayor Watson, who stressed growing concerns over the protestors' occupation of the city, and in particular, described several incidents of protesters engaging in harassment of Ottawa residents, property damage, violence, and other unlawful conduct.

On February 3, 2022, the fundraiser organizer and her team held a press conference to

communicate that the team had been working closely with Ottawa Police and that fundraiser donations would not be given to those violating the law. After the press conference, GoFundMe spoke directly with the organizer and her team. When GoFundMe asked who the team had been coordinating with from the Ottawa Police, the team could not name an individual. GoFundMe also asked how the team was working to ensure that fundraiser donations would not be provided to individuals who were in violation of the law. The organizer's team could not articulate a clear answer and instead responded that it was doing what it could. The team also denied that protestors were engaged in any illegal activities.

On February 4, 2022, GoFundMe again spoke with Deputy Chief Bell, who stated that the situation was escalating, Ottawa residents were legitimately scared, and his department had opened numerous investigations for various acts of unlawful conduct, including harassment, assault, and violence, in connection with the demonstration.

After taking all facts into account, on February 4, 2022, GoFundMe determined that the Freedom Convoy fundraiser no longer complied with its Terms of Service and decided to remove the fundraiser. <sup>11</sup>

## c. GoFundMe has refunded all Freedom Convoy fundraiser donations, including any tip and transaction fee.

On the afternoon of February 4, 2022, GoFundMe removed the fundraiser and provided donors with two options: (1) request a refund based on instructions and an online form provided by GoFundMe, or (2) opt for their donations to go to independent charities "chosen by the Freedom Convoy 2022 organizers and verified by GoFundMe." <sup>12</sup>

GoFundMe initially included the second option for donors because the Freedom Convoy fundraiser organizer had stated on the fundraising page that "[a]ny left over donations will be donated to a credible Veterans organization which will be chosen by the donors," and because the Letter of Attestation agreed to by the organizer stated that the organizer would serve "as a fiduciary for the ultimate benefit of the Convoy Participants and any charitable organizations

chosen to receive any remaining funds," and that "[a]ll funds not distributed to Convoy Participants will be delivered to yet-to-be-determined registered charitable organizations in good standing." <sup>14</sup>

After publicly communicating its decision to remove the fundraiser and the two choices for donors with respect to their donations, GoFundMe learned that its announcement was being misconstrued and misunderstood. GoFundMe discovered on several online and social media platforms multiple false assertions accusing GoFundMe of fraud and misappropriating donor funds. <sup>15</sup>

Shortly after making its announcement, GoFundMe employees experienced a flood of violent and threatening messages, including death threats. <sup>16</sup> GoFundMe became concerned for the safety of its staff.

Furthermore, while GoFundMe and the fundraiser organizer kept an open line of communication up to the point that GoFundMe removed the fundraiser, once GoFundMe alerted the organizer that the fundraiser would be taken down, communications from the organizer ceased. As a result, GoFundMe no longer believed that it would be possible for the organizer and the company to work together in the process necessary for the organizer to choose other charitable organizations as the new beneficiaries of any funds remaining after GoFundMe first returned the donations to those donors requesting refunds.

For the reasons described above, on the evening of February 4, 2022, GoFundMe decided to automatically refund *all* contributions from fundraiser donors. This decision was made in accordance with the Terms of Service, which provide that "GoFundMe may, at any time, for any reason, without notice, and in its sole discretion, offer or issue a refund of [d]onation(s) with or without consulting with [the fundraiser organizer and/or beneficiary], which may comprise the entire amount donated to [the] [f]undraiser."<sup>17</sup>

As explained in GoFundMe's Terms of Service, <sup>18</sup> GoFundMe is not a payment processor and does not hold any funds, nor could GoFundMe redirect funds to itself. Rather, GoFundMe uses third-party payment processing partners to process, hold, and pay out all fundraiser donations. As such, to refund the Freedom Convoy fundraiser donations, GoFundMe worked with its third-party payment processor, Stripe.

On Saturday, February 5, 2022, GoFundMe initiated the automatic refund process through Stripe. The refunds include all donations made from all donors to the Freedom Convoy fundraiser. The refunds include all tips and transaction fees. And the refunds also include all those donations which were already part of the January 27 \$1M CAD distribution (as GoFundMe had not recollected those funds from the organizer), resulting in a significant out-of-pocket loss for GoFundMe of those funds.

No funds donated to the Freedom Convoy fundraiser were distributed to charities.

The Freedom Convoy fundraiser received a total of approximately \$10,000,000 CAD from 133,836 donations. All donors are expected to see a full refund, including any tip and transaction fee, returned to their original payment method. The amount of time it takes for a donor to see the funds returned to their original payment method depends on third-party payment processor and issuing bank times as well as on whether the donor filed a transaction dispute with their credit card issuer. GoFundMe understands that nearly all donors should have seen the funds returned to their original payment method as of the date of this letter. To the extent that this does not resolve the Commission's request, GoFundMe would be happy to provide additional information.

#### II. Ottawa local authorities' statements and testimony about the Freedom Convoy.

As noted, from February 2, 2022, to February 4, 2022, GoFundMe initiated conversations with Ottawa law enforcement leaders and the Ottawa Mayor's office multiple times to get firsthand reporting on the protest. In each conversation, the Ottawa authorities gave a clear and consistent message: (1) the protest was dangerous, (2) protestors were acting violently and unlawfully, and (3) Ottawa residents were facing harassment and assault.

In addition to GoFundMe's communications with the local Ottawa authorities, GoFundMe reviewed public statements about the Convoy protest made by Ottawa law enforcement. These statements included information about Ottawa law enforcement's concern regarding unlawful activities connected with the Freedom Convoy protests, which GoFundMe was informed culminated in more than 200 arrests and criminal charges leveled against more than 100 participating individuals. These public statements include:

- 1. On January 30, 2022, Ottawa police reported that they saw "multiple cases of disruptive, inappropriate and threatening behaviour from demonstrators." <sup>19</sup>
- 2. On January 31, 2022, Chief Peter Sloly remarked that, "[w]e have active criminal investigations undergoing from bribery to threats to assault to the dangerous operation of vehicles."<sup>20</sup>
- 3. On January 31, 2022, Ottawa Mayor Watson remarked that protestors were "harassing," "threatening," and "intimidating," Ottawa residents, and in particular, retail workers. 21 Mayor Watson also provided several examples of the protestors' "disgraceful" behavior, including "stealing from a soup kitchen," and "carrying swastika signs." 22
- 4. On February 1, 2022, the Ottawa police reported that it had charged two protestors with criminal offenses (one protestor was charged with the criminal offense of Carry a Weapon to a Public Meeting) and was investigating the desecration of a war monument.<sup>23</sup>
- 5. On February 2, 2022, Chief Peter Sloly addressed Ottawa residents and described the protest as illegal, specifically with respect to protestors' threatening behavior.<sup>24</sup> That same day the Ottawa police charged a protestor with making threats.<sup>25</sup>

- 6. On February 3, 2022, the Ottawa police reported that it laid multiple charges, among them transportation of dangerous goods and for driving while criminally prohibited.<sup>26</sup>
- 7. On February 4, 2022, the Ottawa police announced additional measures it was taking to protect Ottawa neighborhoods. In doing so, the police noted that its actions were aimed at addressing protestors' "unlawful and threatening; conduct" and the "violence[] and illegal acts" endured by Ottawa residents.<sup>27</sup>

Since the protest, Ottawa Interim Police Chief Bell testified on March 24, 2022, before the Canadian Parliament.<sup>28</sup> In his testimony, Interim Police Chief Bell made the following statements:

- 8. "This unlawful protest was unprecedented. The protestors brought thousands of vehicles to our city with the full intention of disrupting our capital. After they arrived, many chose to stay and were clear in their words and actions that they meant to do damage to our community."
- 9. "Our police service received regular reports of intimidating and threatening behaviour towards residents on a daily basis. We had reports of hate crimes being committed and of willful disregard of police and court orders. The protesters used their vehicles as tools to back up their behaviour, honking their horns and racing dangerously around streets in the downtown core."
- 10. "Despite our attempts to negotiate or threats of investigation and enforcement, the illegal and disruptive behaviors continued throughout the protest and became elevated on weekends when more protestors arrived."
- 11. "During the protest, we saw clear signs of hate, such as swastikas, anti-government sentiment, leaders posting threatening language on social media and other various forms of social disorder."
- 12. "In total, there were 230 arrests, and 118 people were criminally charged with more than 400 criminal counts. Hundreds of provincial offence notices were issued. There are cases that are still moving through the courts, and multiple investigations are ongoing."

13. "As the protest/demonstration unfolded, we quickly identified it as an illegal occupation of our streets."

O. not to attempt to undertake indirectly any of the foregoing.

Additionally, with respect to all Donations you make or accept through the Services, you agree and represent, warrant and covenant:

A. not to make or accept any Donations that you know or suspect to be erroneous, suspicious or fraudulent;

B. not to use the Services in or for the benefit of a country, organization, entity, or person embargoed or blocked by any government, including those on sanctions lists identified by the United States Office of Foreign Asset Control (OFAC);

C. to maintain reasonable and standard security measures to protect any information transmitted and received through the Services, including without limitation, adhering to any security procedures and controls required by GoFundMe from time to time;

D. to maintain a copy of all electronic and other records related to Fundraisers and Donations as necessary for GoFundMe to verify compliance with these Terms of Service and make such records available to GoFundMe upon our request. Donations made through PayPal Giving Fund are governed by the Privacy Policy and User Agreement of PayPal Giving Fund and PayPal.

iii. PayPal Giving Fund has foreign counterparts, which are also registered charities in those countries. For example, if an Organizer in the United Kingdom starts a Fundraiser for a Charity in the United Kingdom, then PayPal will act as the Payment Processor with PayPal Giving Fund UK receiving the Donations. Thereafter, PayPal Giving Fund UK will grant funds to the Charity identified in the Fundraiser, to the extent it is able, and it will issue country dependent tax documentation for all Donations received through it.

Donations will appear on the Donor's credit card statement under the name of the Charity to which the Donor contributed. The Chair (Hon. Jim Carr (Winnipeg South Centre, Lib.)): Good morning, everyone. I call this meeting to order. Welcome to meeting No. 14 of the House of Commons Standing Committee on Public Safety and National Security.

We will start by acknowledging that we are meeting on the traditional unceded territory of the Algonquin people.

Today's meeting is taking place in a hybrid format, pursuant to the House Order of November 25, 2021.

Colleagues, I don't have to read about all of the public orders and the way that we keep our distance. We wear masks when we are not speaking. Staff wear masks at all times please. We will run the meeting as efficiently as we can. Members will be participating virtually and they may speak in the official language of their choice. Interpretation services are available for the meeting. You have the choice at the bottom of your screen of either floor, English, or French. If interpretation is lost, please inform me immediately and we will set it right.

When speaking, please speak slowly and clearly. Should any technical challenges arise please advise me.

Pursuant to Standing Order 108(2), and the motion adopted by the committee on Tuesday, February 15, 2022, the committee is resuming its study of the occupation of Ottawa and the federal government's response to convoy blockades.

With us today by video conference Commissioner Thomas Carrique of the Ontario Provincial Police. Deputy

commissioner Chris Harkins, and chief superintendent Carson Pardy. From the Ottawa Police Service, Steve Bell, interim chief, and Trish Ferguson, acting deputy chief. Welcome to all of you.

Up to five minutes will be given for opening remarks after which we will proceed with rounds of questions.

Interim Chief Bell, I now invite you to make opening remarks of up to five minutes. Chief Bell, the floor is yours please proceed.

Mr. Steve Bell (Interim Chief, Ottawa Police Service): Thank you very much, Mr. Chair. I share your passion for well-run meetings so thank you for that. Distinguished members of the committee I'm pleased to be given this opportunity to meet with you today.

The Chair: I'm sorry we're going to need more volume.

**Mr. Steve Bell:** Joining me today is Deputy Chief Trish Ferguson, who was the operational lead for the successful resolution of the illegal protest.

We're here today to answer questions about the illegal protest that occurred in Ottawa between January 28, 2022 and February 20, 2022.

As the police service of jurisdiction in the nation's capital, our members are well-practiced in keeping the peace during public demonstrations.

Every year, hundreds of protests occur in our capital. Our officers are trained to maintain the safety of both the demonstrators and the public at large. The vast majority of these protests are peaceful and lawful, and protesters return home when their point has been made.

This unlawful protest was unprecedented. The protesters brought thousands of vehicles to our city with the full intention of disrupting our capital. After they arrived, many chose to stay and were clear in their words and actions that they meant to do damage to our community.

Our police service received regular reports of intimidating and threatening behaviour towards residents on a daily basis. We had reports of hate crimes being committed and of wilful disregard of police and court orders.

The protesters used their vehicles as tools to back up their behaviour, honking their horns and racing dangerously around streets in the downtown core.

Despite our attempts to negotiate or threats of investigation and enforcement, the illegal and disruptive behaviours continued throughout the protest and became elevated on weekends when more protesters arrived.

Our response as a police service, along with our many partners, was to work to safely manage the disruptions, contain the behaviours and negotiate the protesters out.

In the early days we were able to ensure that no serious injuries, deaths or damage to infrastructure was committed. But that's not the standard of policing any resident of our city or any Canadian would expect.

As a police service, we understood quickly that we needed assistance from all levels of government in the form of legislative powers and policing resources if we were to safely remove this unlawful protest from our streets.

It's important that this committee understand and appreciate the negative impacts this behaviour had on our entire community and our businesses, and especially the impacts on our vulnerable, marginalized, indigenous, 2SLGBTQAA+ and racialized communities.

Our Centretown is a diverse, proud and vibrant place. During the protest, we saw clear signs of hate, such as swastikas, anti-government sentiment, leaders posting threatening language on social media and other various forms of social disorder. It shook the community's faith and confidence in the ability of police and government to keep them safe. We have seen the same effects in cities such as Calgary and Windsor and in Coutts, Alberta, where similar protests were held.

Our goal from the outset was always to remove this protest safely. In order to do that, it required the careful coordination between all of our policing partners to develop a strategy that would ensure a safe resolution.

All three levels of government responded with legislative measures that aided our strategy. I want to thank the City of Ottawa and the Ontario government for the changes brought forward. I also want to thank the federal government for invoking the federal Emergencies Act.

From a policing perspective, the legislation provided the OPS the ability to prevent people from participating in this unlawful protest; to restrict people from travelling to any area where the unlawful protest was taking place; to secure protected places and critical infrastructure; to create and maintain the secured area to prevent people from violating the act and safely remove people who were attempting to do so; to go after the money funding the protest; and to require third parties to assist in removing the heavy vehicles that were clogging streets and creating a safety hazard. It was a critical piece of our efforts, but it was only one piece.

Another critical piece was the rallying of police resources from the RCMP, the OPP and police services from across Canada. I want to thank them all for their support.

As you saw, once we had all of those authorities and those resources in place, we were able to implement a methodical police operation, between February 17 and February 20, with an integrated command led by the Ottawa Police Service, the Royal Canadian Mounted Police and the Ontario Provincial Police to safely remove the protest.

In total, there were 230 arrests, and 118 people were criminally charged with more than 400 criminal counts. Hundreds of provincial offence notices were issued. There are cases that are still moving through the courts, and multiple investigations are ongoing.

There is no doubt, in a democracy such as Canada, that a discussion and assessment on the appropriateness of the invocation of the Emergencies Act, which provided police broader powers, is important. I am pleased to be here to contribute to that discussion.

I can tell you that police chiefs across the country are watching this discussion, because they know that similar situations could, or are, occurring in their jurisdictions. I have spoken to many of them who have sought out advice.

Finally, I want to reiterate my pride in all of the police members who worked on this operation, including the members who came from across Canada to assist us. This was truly a Canadian effort and it showed the vital role police play in maintaining our democracy and keeping our residents safe.

Deputy Chief Ferguson and I look forward to answering your questions today.

The Chair: Thank you very much, Interim Chief.

Now I would like to call on Commissioner Thomas Carrique. Sir, you have five minutes for an opening statement. The floor is yours.

# Commr Thomas Carrique (Commissioner, Ontario Provincial Police): Thank you, Chair.

Good morning Chair, vice-chairs and committee members. I am joined here today by Ontario Provincial Police deputy commissioner, Chris Harkins; and chief superintendent, Carson Pardy.

Under the Ontario Police Services Act, the OPP has a unique dual mandate providing frontline policing services to 328 municipalities across the province, as well as providing assistance and/or specialized support to municipal services upon request.

As it relates to the "freedom convoy", and the associated illegal blockades in the city of Ottawa, the OPP's intelligence bureau commenced reporting to our policing partners on January 13, 2022. As of January 22, daily intelligence reports focused on the convoy headed to Ottawa and the anticipated protest movements across the province.

The intelligence reporting was shared with more than 35 Canadian police, law enforcement and security agencies.

As the convoy crossed over the Manitoba-Ontario border and travelled across the province, until it arrived in Ottawa on January 28, OPP officers professionally fulfilled their duties without incident.

In support of the Ottawa Police Service, throughout the occupation, an increasing number of OPP officers and specialized resources from various services became engaged, ultimately contributing to an integrated plan and the establishment of a unified command.

Simultaneously, our members responded to many other convoys and demonstrations that consistently and repeatedly emerged in communities across Ontario. Including, but not limited to, the critical blockage of the Ambassador Bridge, the blockade of Highway 402, multiple other attempts to block Canada-U.S. land border crossings, and demonstrations that posed a risk to the area of the Ontario Legislature.

In addition, from day one, when the convoy entered Ontario, we were responsive to requests for assistance from other municipal police services. This was a provincial and national emergency that garnered international attention.

In response, the OPP and more than 20 other police services from across the country worked collaboratively to address public order emergencies that were unmatched in recent history. Protests and demonstrations are often complex in nature. The role of the police remains that of protecting the public, upholding the law and keeping the peace.

The province's Critical Infrastructure and Highways regulation under the Emergency Management and Civil Protection Act, and the federal Emergencies Act were effective supplementary tools needed to help protect critical infrastructure and ensure the continuous and safe delivery of essential goods and services, while at the same time, maintaining, or in the case of Ottawa, restoring peace, order and public security.

As the committee is well aware, in addition to the critical events experienced in Ontario, the illegal Ottawa occupation was accompanied by numerous other high-risk, "freedom convoy"- related protests and blockades across Canada. The OPP worked collaboratively with the Ottawa Police Service, the Royal Canada Mounted Police and other policing partners to develop a sustainable integrated operational plan that was informed by best practices from other high-risk critical events, available police resources, along with other concurrent and emerging operational requirements in a number of police jurisdictions.

Sufficiently trained public order officers were amassed from throughout Canada and deployed in an integrated, strategic and measured manner which resulted in the collapse of the occupation. The situation, and the associated events simultaneously taking place across Canada, required unprecedented national collaboration to prevent injury, preserve life and protect critical infrastructure.

As the commissioner of the Ontario Provincial Police, I am extremely proud of the remarkable professionalism and dedication of the officers deployed to Ottawa and the other high-risk events simultaneously occurring across the province. Despite all the challenges, while the entire nation watched live, our officers and those from a multitude of other Canadian police services, remained committed to their roles and responsibilities, and represented the entire policing profession with the upmost professionalism, discipline and competence.

Thank you. Meegwetch.

The Chair: Thank you very much, Commissioner. We appreciate your opening remarks.

Colleagues, I'll now open the floor to questioning.

Mr. Lloyd, you are first up for a six-minute round. The floor is yours, sir.

Mr. Dane Lloyd (Sturgeon River—Parkland, CPC): Thank you, Mr. Chair.

Interim Chief Bell, in Ottawa, during the protest clearing operation, where any loaded shotguns found in the trucks of protesters?

**Mr. Steve Bell:** Mr. Chair, what I can indicate is that throughout the protest we did receive information and intelligence around weapons and the position of weapons by people that either had attended or intended on attending the occupation.

As a result of the clearing, at no point did we lay any firearms-related charges, yet there are investigations that continue in relation to weapons possessions at the occupation.

**Mr. Dane Lloyd:** Yes or now, Interim Chief. Were loaded firearms found int he truck during the protest clearing operation?

**Mr. Steve Bell:** As I indicated, Mr. Chair, there has been no charges laid to date in relation to weapons at the occupation site.

**Mr. Dane Lloyd:** It's a clear question, Interim Chief. Were weapons found? Were loaded firearms found, yes or no?

Mr. Steve Bell: No, not relating to any charges to this point.

Mr. Dane Lloyd: Thank you, Chief. That's very illuminating.

On March 19, this past Saturday, a reporter, Justin Ling, wrote in the *Toronto Star* the following.

Police sources indicated that loaded shotguns were found in trucks at the Ottawa protest.

Is this false information?

**Mr. Steve Bell:** I'm unfamiliar with the quote you're referring to, but as I indicated before, we received intelligence information, we continue criminal investigation, and no charges have been laid to date in relation to firearms.

**Mr. Dane Lloyd:** But the article claims that a police source told the journalist that loaded shotguns were found in trucks during the protest-clearing operation. You have said to this committee that is in fact not the case, that loaded shotguns were not found in trucks during the protest clearing operation.

Is that the case, Interim Chief?

Mr. Steve Bell: Thank you for the question, Mr. Chair.

As I indicated, we received intelligence information. I'm unclear around the source of information that was received through that article or the corroboration around it. We have not laid any charges—

**Mr. Dane Lloyd:** Interim Chief, can you clarify, speaking on the record, not off the record, that loaded shotguns were not found int he vehicles during the protest operation? Can you confirm that?

Mr. Steve Bell: Consistent with my answer previously, yes. I can confirm to date no charges have been laid.

**Mr. Dane Lloyd:** If there had been firearms found, would the government have been made aware of that, as car as you know? Would the cabinet been made aware of that if there had been firearms found?

Mr. Steve Bell: Our normal course of action would be that we would conduct an investigation and charges would be laid. As a result of those charges there would be public notifications of those charges. We wouldn't specifically notify any level of government as to the course or the conclusion of any investigation.

Mr. Dane Lloyd: But they would have been immediately aware if you had found firearms. Correct?

Mr. Steve Bell: There would have been public notifications made.

**Mr. Dane Lloyd:** We had a cabinet minister, the Minister of Crown Indigenous Relations, Marc Miller, retweet that article from Justin Ling from the *Toronto Star* claiming that there were loaded shotguns found in trucks. This is misinformation, Chief.

I submit to the committee, this is misinformation being spread by a journalist and misinformation being spread by a member of this government. I'll close my remarks and give my time to Mr. Shipley.

Thank you, Mr. Chair.

Thank you, Interim Chief.

Mr. Doug Shipley (Barrie—Springwater—Oro-Medonte, CPC): Thank you, Chair.

First of all, I'd like to thank all the witnesses who are here with us today. I witnesses first-hand what went on here in Ottawa. Both your services, in very trying times—I spoke to many officers out there—handled themselves in a very professional manner.

I'd first like to direct a couple of my questions to Commissioner Carrique.

Hello, Commissioner Carrique. I understand we have some mutual acquaintances.

My questions today are based on.... I had the opportunity to speak to two previous commissioners of the OPP as this was going on, trying to get some information. One of them told me an interesting statement that you will never find a police service that would turn down additional powers.

Would you agree with that statement, Commissioner?

Commr Thomas Carrique: Thank you.

Through you, Mr. Chair, I would like to know the context of the statement. I don't know that we are in a position to turn down additional powers. We utilize the laws that are provided to us. We do so in a judicious manner consistent with the charter of rights and freedoms.

Mr. Doug Shipley: Thank you for that.

I'm not giving you all the details on that, so I know I kind of put you on the spot. It was around, obviously, the Emergency Measures Act and how that could help some services. Also through those discussions with those two past commissioners, they both felt the Emergency Measures Act was not required in clearing this.

Could you elaborate on that? Do you agree with your past predecessors on this?

**(1120)** 

Commr Thomas Carrique: I can say the Emergencies Act was an extremely valuable tool. This was identified as a threat to national security. We were able to utilize a number of the powers in the Emergencies Act, specifically prohibiting people from attending designated areas, limiting the presence of children, which created a significant public safety risk, compelling service providers to assist with the removal of vehicles that required heavy tows, providing indemnification for those service providers and the freezing of accounts. These tools made our operation very effective and, in the absence of having those tools, we could have not have been as effective as we were.

The Chair: Thank you very much.

I would know like to invite Mr. Noormohamed, for six minutes of questioning.

Sir, over to you.

Mr. Taleeb Noormohamed (Vancouver Granville, Lib.): Thank you, Mr. Chair.

I'd like to thank both of you for being with us today.

I'd like to start with Interim Chief Bell.

Thank you so much for your opening comments. I think they were important for all of us to hear.

I just want to clarify something that was asked of you. I know my colleague, Mr. Lloyd, is not here, but I think it's important for the record.

Just to be clear, you had said there has been no charges laid to date related to firearms. Is it possible that charges could still be laid related to firearms?

Mr. Steve Bell: Mr. Chair, thank you for the question.

We don't specifically comment on the progress of ongoing investigations. As I indicated in the answer, information and intelligence was received prior to the demobilization of the demonstration around the existence of firearms within the footprint. Investigations relating to weapons offences continue. Upon the completion of them, we'll be able to provide information, if, ultimately, there are charges laid. But to date there has been no firearms-related charges laid in relation to our takedown.

## Mr. Taleeb Noormohamed: Thank you.

There has been, as you know, a lot of interest across Canada in what happened in Ottawa. Many of us receive emails from people with information about how they believe things went down in Ottawa. If you'd indulge me, I have a few questions I just want to ask you just to clarify things that you had said in your opening statement for folks across the country, so there isn't misinformation about what happened in Ottawa.

Would you classify what happened in Ottawa as a peaceful, unobstructed protest?

**Mr. Steve Bell:** Mr. Chair, as I indicated in my statement, no, I wouldn't. As the protest/demonstration unfolded, we quickly identified it as an illegal occupation of our streets. Beyond our own observations of it, that was by far and large the sentiments we were receiving from our community: that the activities ongoing within the streets were extremely disruptive and made them fear for their own safety within their community.

So, no, I do not believe this was a lawful demonstration within our streets, and for those reasons we took the course of action we did to ultimately remove them.

#### Mr. Taleeb Noormohamed: Thank you.

Interim Chief, again, just to clarify for folks who may not have heard your statement, were there multiple reports of allegations of hate crimes?

Mr. Steve Bell: The existence of undesirable, intolerable, criminal behaviour the residents of our city were subjected to are well documented through the course of our investigations and through the course of the unfolding of our dismantling of the occupation. What I can tell you is all through the occupation we had conversations with our community, where they demonstrated and identified and reported incidents of hate-based crimes and incidents they were experiencing within their streets. We continue to investigate those. We continue to look at the community healing and reparation that we know needs to go on within our community based on the intolerable circumstances and behaviours they were subjected to.

#### Mr. Taleeb Noormohamed: Thank you.

People had been told there had been reports of visible minorities, of indigenous people, of women, of vulnerable communities being harassed, being made to feel unsafe, and they were told not to worry because this was a peaceful protest. Do you believe they had reason to worry?

**(1125)** 

Mr. Steve Bell: Mr. Chair, I think it's a very interesting question and I don't think I'm the one properly situated to

answer it.

What I can tell you is the experience of the community members that we spoke with experienced that. They felt unsafe in their communities. They were terrorized by activity that occurred in interactions with them relating to people who were present in and around the occupation. They experienced incidents of hate, biased crimes, and biased incidents, in their interactions. Their very real, very relevant, experiences are exactly that; they felt unsafe within their own communities.

Mr. Taleeb Noormohamed: Interim Chief, as you reflect on what was going on and having heard from your community, how did you feel when you saw political leaders encouraging or supporting the blockade and defending the actions of those who were occupying your city?

**Mr. Steve Bell:** Mr. Chair, my focus throughout this was to work with my policing partners.

I would like to publicly thank Commissioner Carrique and Commissioner Lucki for the amazing support that they provided throughout this. When it came to our interactions with various levels of government our sole focus was around looking at how we identify accessing the resources and supports that we need and how we look at leveraging the adequate tools including the legislative changes like the Emergencies Act that we ultimately received. When it came to political and government operations that is where our sole focus was.

Mr. Taleeb Noormohamed: We have a very short amount of time left.

I'm going to ask you two very quick questions and I'd really appreciate your answers.

A lot of folks said that the protest only became illegal after the Emergencies Act was invoked.

Could you share your perspective on that very quickly? Could you also share if in fact laws and statutes were broken prior to the Emergencies Act being invoked?

Could you also confirm or deny that "a large number of—

The Chair: I'm sorry.

He's only going to have 10 seconds to answer both.

Mr. Taleeb Noormohamed: Okay.

Could you confirm your perspective on whether the Emergencies Act was needed or not?

The Chair: Time's up. Sorry.

I'll give you 10 seconds to answer, Interim Chief.

Mr. Steve Bell: That's a challenge.

The unlawful activity progressed throughout the course of the occupation. That is, from the time that people did not leave. What could have been a lawful demonstration to, ultimately, our take-down, lawful activity was observed, documented, and prosecuted.

The Chair: Thank you very much.

I'll now call on Ms. Michaud to begin her six minute question slot.

The floor is yours.

Mme Kristina Michaud (Avignon—La Mitis—Matane—Matapédia, BQ): Merci, monsieur le président.

Je remercie les témoins de leur présence. C'est très apprécié.

Nous avions hâte de vous entendre. J'en profite pour vous remercier de votre travail, remercier vos agents également, lesquels ont quand même mis en place une opération d'envergure pour déloger les manifestants qu'on a vus, pendant plusieurs semaines, sur la Colline du Parlement.

Or, il y a une question qui me vient tout de suite en tête: pourquoi cette opération n'a-t-elle pas eu lieu avant cela? Pourquoi cela a-t-il duré si longtemps avant qu'on puisse la mettre en place?

Je ne peux pas m'empêcher de faire le parallèle avec ce qui s'est passé dans la ville de Québec. À partir du moment où on a eu l'information qu'il y avait des gens qui se dirigeaient pour manifester devant le Parlement et devant l'Assemblée nationale à Québec, le maire de Québec et le premier ministre du Québec ont fait des mises en garde. Ils ont dit qu'ils ne tolèreraient pas de dérapage. Les policiers ont bloqué l'accès au Parlement. Il y avait des policiers de la SQ et du service de police de la ville de Québec à peu près partout dans la ville, ou près de la Colline du Parlement et dans les rues avoisinantes. Il y avait des remorqueuses qui étaient prêtes.

Je me demande, du côté de votre préparation, à partir de quel moment vous avez su qu'il y avait des gens qui s'en venaient vers la Colline du Parlement. Quelle a été votre préparation? Quelle a été la collaboration avec les autres services de police, avec les paliers du gouvernement et avec la Ville d'Ottawa? Comment vous êtes-vous préparés à accueillir ce convoi qui se dirigeait clairement au centre-ville d'Ottawa?

Ma question s'adresse peut-être à M. Bell en premier.

Mr. Steve Bell: Thank you, Mr. Chair.

One of the things that I think is really important to highlight is that as the police jurisdiction in Ottawa, on a yearly basis we deal with hundreds of demonstrations. As the seat of Parliament for the nation, as the police jurisdiction in that nation's capital, it is what we do. On a daily basis, we manage, support, liaise and work with protesters and demonstrators in our jurisdiction for them to engage in their lawful right to have their voices heard.

This circumstance was unprecedented to any of those other circumstances that we'd seen previously. On previous occasions within the last six months prior to this, we'd had several demonstrations that were centred around vehicles attending our jurisdiction to have their voices heard.

All of the past history that we had was around people attending, having their voices heard and then leaving, as is their constitutional right. We prepare, we support and we work with protesters to look at how we best manage their safety and the safety of the community.

What I can tell you is that as this built, as this moved across the country and as it ultimately settled down into our jurisdiction—ultimately occupying our streets—this grew to be a very different circumstance from any other protest or demonstration that we had managed in the past. The very outcome of it identifies how different it was.

Last year, during our protests, we had fewer than five arrests associated with demonstrations and demonstration activity. In this protest, we had 280 arrests that resulted in hundreds and hundreds of criminal charges. Those were not the circumstances that existed prior to this demonstration occupying our streets.

Since this has occurred—

**Mme Kristina Michaud:** Monsieur Bell, je n'ai pas beaucoup de temps. Je me permettrais de retourner à la question principale. Vous avez dit, dans votre allocution d'ouverture, que l'intention des manifestants était clairement de troubler l'ordre public et de venir déranger le centre-ville. Il y avait des signes de haine. Vous dites maintenant que c'est quelque chose que vous n'avez jamais vu auparavant.

On voit chaque semaine ici devant le Parlement des gens qui viennent manifester et qui veulent se faire entendre, mais ceux dont on parle avaient clairement l'intention de rester ici. Ils disaient aux médias qu'ils ne s'en iraient pas

tant qu'ils n'auraient pas ce qu'ils voulaient. On voyait donc qu'il y avait cette intention d'aller un peu plus loin. Comment vous êtes-vous préparé à cela?

J'ai l'impression qu'à un moment donné, cela a pris une ampleur incroyable. Une personne du service de police de la ville d'Ottawa a signé une lettre destinée à M. Trudeau et à M. Watson pour demander 1800 agents supplémentaires. C'était autour du onzième jour ou du douzième jour. Ces outils-là auraient pu vous permettre d'agir plus rapidement. Comment vous êtes-vous préparé donc? Quand vous avez demandé de l'aide, est-ce que vous avez été entendu?

Mr. Steve Bell: I think you've identified scope and scale that are very important factors that play in this. The original intelligence that we had had a much smaller footprint of the people who were—what I would call—motivated to stay for longer periods of time. What ultimately ended up on our streets in terms of scope and scale—geographical footprint—was not consistent with what we believed or what we believed to have intended to occur.

Beyond that, the activities that were engaged by the protesters were not what we believed would occur, were not consistent with previous demonstrations that had occurred in our streets. The hate, the disruptive behaviour, the intimidating behaviour, the noise pollution that terrorized our communities—24 hours a day, seven days a week—were nothing that was indicated to have occurred before.

You mentioned the preparations of other jurisdictions. What I can tell you is through conversations with many other chiefs of police that continue to be ongoing now, much was learned from what occurred in Ottawa.

Chief Ramer from Toronto clearly indicated—

**The Chair:** Thank you very much. Sorry, interim Chief, we're out of time on that block.

I'd like to turn now to Mr. MacGregor. Sir, you have six minutes. The floor is yours.

Mr. Alistair MacGregor (Cowichan—Malahat—Langford, NDP): Thank you so much, Chair.

Chief Bell, I'm going to continue with you. Your opening remarks quite skillfully and completely deconstructed the narrative that this was a peaceful protest. I appreciate your providing Ottawa Police Service's perspective on what your officers were dealing with.

I want to go through this timeline because the convoy arrived in Ottawa on the weekend of January 28. On February 6, we had Ottawa declare a local state of emergency, followed by February 11, when the Province of Ontario followed suit. Then, on February 14 was the federal state of emergency. With the two previous states of emergency, both Ottawa and the Province of Ontario, there have been a lot of questions as to why existing laws were not sufficient to deal with this protest. Why did we get to the point, on February 14, where federal powers were necessary?

Can you please explain to the committee why a local state of emergency, and then a provincial state of emergency, were not enough to deal with the occupation of Ottawa?

**(1135)** 

Mr. Steve Bell: Thank you for the question, Mr. Chair.

As I indicated in my statement, and as Commissioner Carrique reiterated in his opening statement, there were several factors and several pieces that needed to come into play for us to be able to successfully and safely end the occupations of our streets.

One of those pieces was the injunctions levelled within the City of Ottawa. Another piece was the provincial state of emergency and emergencies act that were implemented. The final piece to that was the Emergencies Act. They all provided different components, legislation and tools for us that were utilized to ultimately and successfully take down the demonstration that was occurring.

Beyond the tools we had, we needed to amass the resources. We did ultimately have just shy of 2,000 police members attend our city streets in order to be able to successfully dismantle this.

So we needed, not only tools, but resources and the plan. That all culminated in the ultimate take-down that you were able to witness.

Mr. Alistair MacGregor: I think that residents of Ottawa still have a lot of questions about their police service and the actions that led up to the declaration of emergency.

We had media reports and saw pictures of police officers standing by while people were carting jerry cans of diesel fuel. A lot of residents, rightfully, have questions as to why those officers were not enforcing the law at that time. Can you provide some illumination as to why that did not occur?

**Mr. Steve Bell:** Mr. Chair, I'll concur at the very beginning. Residents of our city do have questions about our activities as we led up this. I have questions about our activities leading up to this. That's why discussions like these and the internal review that's going to be done by the City of Ottawa are so important. We need to learn from these circumstances. We need to make sure that something like this never replicates again.

This was an unprecedented, unseen event for any jurisdiction across Canada. The members of our police service, our unified command team between the RCMP and the OPP were dealing with a situation that had never been tackled, had never been approached before.

We went through a series of methodical planning, a series of resource gathering and ultimately utilized the tools that were presented to us in order to safely take down this demonstration and the illegal occupation of our streets.

Mr. Alistair MacGregor: I just need to interject. I'm sorry, I have limited time here.

I just want very quickly from you, on what date did you feel that the protest had moved into an illegal occupation?

**Mr. Steve Bell:** As I indicated, as the protest grew in scope and scale and as we observed the activities of the members, it turned from what would have been a demonstration to an illegal occupation very early in—

Mr. Alistair MacGregor: So it was very early.

There are reports that some members of the Ottawa Police Services donated funds through GiveSendGo to contribute to the illegal occupation. Police officers are necessarily held to a higher standard because of the role they play in our society. What does it say when we have police officers funding an occupation that is actively undermining the residents' right to peace and security and the ability to go about their daily business?

**Mr. Steve Bell:** Mr. Chair, that is an extremely important question and one that has been asked of me many times and I've been very clear around that.

People who support—members who support—this activity do not share the values of this organization and we have already commenced and initiated investigations that will look to fully discipline, within our authorities, any misconduct that's identified.

I also think it's really important to balance that. The vast majority of the members of this police service, the members of the OPP and the RCMP and every police member that attended our city did it with the values that we hold and share to make sure that these illegal activities and occupation of our streets were removed so that the streets could be given back to our citizens. I think that's the important thing to focus on.

**(1140)** 

**The Chair:** Thank you very much, Chief.

Thank you, Mr. MacGregor.

We'll now move into the second round of questions. That begins with Mr. Brock, who will have five minutes. Sir, the floor is yours.

Mr. Larry Brock (Brantford—Brant, CPC): Thank you, Chair.

Thank you to the witnesses for your presence today and testimony.

Largely my questions will be directed towards Interim Chief Bell.

Interim Chief Bell, just a little bit of background, we know that there were a number of other similar based protests around this country. We know there were border disputes in Alberta, Manitoba and at the Windsor Ambassador Bridge. You'll agree with me, Officer, that those disputes were all resolved, removed and charges laid without the invocation of the Emergencies Act. Yes or no?

Mr. Steve Bell: Mr. Chair, I would debate the definition of "similar". Border protests in non-residential areas are considerably different than an occupation of what amassed to approximately 20 square blocks in the centre of a major municipality within the country, in front of a Parliament who had to suspend sitting for a period of time so that the police operations could be undertaken. The characterization of the other three demonstrations and where they were situated, as well as scope and scale...I don't think it's comparable to what happened within the streets of Ottawa.

Mr. Larry Brock: You'd also agree with me, Officer, that in fact, part of the wording of the statute is that the invocation can only take place where there are no other existing laws in Canada to remove the nuisance or dispute.

You'd agree with me in these circumstances there were a myriad of Criminal Code charges, Highway Traffic Act charges, City of Ottawa municipal bylaws, as well as several Superior Court orders that could have been utilized by the rank and file of the Ottawa Police Service, but there were no charges laid before the invocation of the Emergencies Act.

Do you agree with that Officer, or not?

**Mr. Steve Bell:** I do not, because there were several criminal charges laid in the course of our enforcement through the process of stabilizing, maintaining and ultimately removing the demonstrators from our streets.

The Emergencies Act—

Mr. Larry Brock: I'm sorry to interrupt, was that before or after the invocation of the act?

Mr. Steve Bell: There were criminal charges laid prior to the invocation of the Emergencies Act.

Mr. Larry Brock: Okay, what charges were they? Were they Criminal Code charges?

**Mr. Steve Bell:** Absolutely. There were Criminal Code charges related to activities surrounding the demonstration.

**Mr. Larry Brock:** You mentioned racing dangerously around the city core. Those laws exist under the Highway Traffic Act. Presumably that wasn't simply a report that was generated to the Ottawa Police Services. Hundreds and hundreds of your rank and file Ottawa Police Service members were able to witness that dangerous behaviour and yet no charges were laid in relation to that conduct.

You'd agree with me?

**Mr. Steve Bell:** As I indicated in my opening, the Emergencies Act was one of the tools that we utilized. What specifically it provided us was the ability to create an exclusionary zone. One of the major issues that we had in trying to manage and maintain was the free flow of people in and out of the demonstration footprint—the red zone, as we called it. [*Inaudible*].

Mr. Larry Brock: I get that.

Chief Bell, thank you. I've got a limited amount of time. That does not answer my question.

My question is, there were a number of Highway Traffic Act infractions and Criminal Code violations being

conducted in the presence of police officers, where no charges were laid. What direction did leadership give to the rank and file to turn a blind eye to this illegal behaviour that only became necessary in terms of exercising your duty as a police officer after the invocation of the act?

The Chair: You've got 15 seconds, Chief.

Mr. Steve Bell: There was no direction to disregard criminal activity or highway traffic activity. In fact, what we have done is gathered information, intelligence, and we continue to do investigations around that very activity you're discussing.

What was paramount for us was the safety of the community, the safety of our officers, and the safety of the demonstrators, and on several occasions that safety was—

The Chair: I'm sorry for interrupting, it's not the best part of my job but it's an important part.

Now we turn to Mr. Naqvi who has five minutes, I believe joining us remotely.

Mr. Naqvi.

Mr. Yasir Naqvi (Ottawa Centre, Lib.): Thank you very much.

Thank you, Mr. Chair, I hope you can hear me clearly?

The Chair: Yes, fine.

Mr. Yasir Naqvi: Thank you to all the officers who are here today.

I'm going to be focusing my questions to Interim Chief Bell.

Chief Bell, thank you for being here and being so forthcoming in answering questions.

I'm going to be asking some really basic fact-based questions, questions that I'm hearing directly from the community that I represent. As you know, I represent Ottawa Centre that was the ground zero of this illegal occupation, and the questions that I think you've been asked as well by our citizens of our community.

Let me start by asking this question, is it the general practice for Ottawa police to let vehicles park on Wellington Street?

- Mr. Steve Bell: Mr. Chair, as I indicated in an earlier answer, at various times as it relates to different protests that have occurred in the past, and in the very near past, provisions are made to allow vehicles into that area, to have their voices heard and they then leave at the end of that.
- Mr. Yasir Naqvi: Have we in the past for various protests, and as you mentioned we get protests often on parliamentary precinct, have you allowed for cranes to be mounted right in front of Parliament Hill?
- **Mr. Steve Bell:** Sorry, Mr. Chair, if it's specifically relating to the fact do we allow cranes and do we manage the access to that, yes absolutely, that is one of the functions of the Ottawa Police Service.
- **Mr. Yasir Naqvi:** We don't allow those type of equipment as part of a protest to be stationed on Wellington Street?
- Mr. Steve Bell: Mr. Chair, it depends on the context of the protest. We, as a police service, attempt to facilitate the lawful right to people have their voices heard. There are many different communities that we have facilitated that ability in different ways in the past.

In the past summer, we had a farmers protest that had multiple dozens of tractors occupying that same area. In the past we had trucking association demonstrations that have had vehicles come, park in that area, drive around in different areas, get their message across and then ultimately leave the jurisdiction, as is the course of a normal

protest.

**Mr. Yasir Naqvi:** Chief Bell, I've seen a lot of those protests as well, it was highly unusual to see a crane right in front of the Privy Council and the Prime Minister's office.

Let me ask you this question, did this protest have a permit to hold a protest at Parliament Hill?

Mr. Steve Bell: As the police jurisdiction for Ottawa, we would not provide permits for people to protest within the parliamentary precinct, that's not within our area of jurisdiction. We would be able, and no ourselves but us through our city partners, to issue permits for demonstrations and protests that were to occur within our city streets.

I can tell you as a result of the ongoing pandemic those permits have been suspended so any protest within the time span of the pandemic has not received a permit because they have not been sanctioned by the city.

Mr. Yasir Naqvi: Thank you.

The protest started around January 28, after the first weekend, just around February 1 or 2, Tuesday or Wednesday, I recall seeing a news release from Ottawa police that clearly said that there's about 200 to 250 protesters with a couple of hundred of vehicles.

As you stated a few laws were being broken, why didn't the Ottawa police at that time, move in and enforce the existing laws at their disposal to remove the occupiers?

**Mr. Steve Bell:** As I indicated before, I think it's important to understand the scope, scale, and magnitude of the operation we undertook. I understand people have witnessed and observed how many police officers it took to come here, the amendments of powers that we needed in order to be able to create a safe environment in order to begin that operation. That took time as it moved through.

The numbers of people involved in the protest site fluctuated, but the number of vehicles did not dramatically fluctuate. And the vehicles were an impediment to us—

The Chair: Ten seconds, Chief.

Mr. Steve Bell: —a concern and something that was different for us in dealing with.

Mr. Yasir Naqvi: But Chief, in the eventual operation, you removed [Inaudible] vehicles.

The Chair: Sorry, we're out of time. Mr. Naqvi, you're out of time, sir. We have to move on.

We move to Ms. Michaud. You have all of two and a half minutes. Make good use of it.

Mme Kristina Michaud: Monsieur le président, je vous remercie. C'est ce que je vais essayer de faire.

Je vais reprendre là où je me suis arrêtée tout à l'heure avec M. Bell.

Monsieur Bell, vous disiez que les autres à Québec étaient peut-être un peu mieux préparés parce qu'ils se sont inspirés de ce qui s'est passé ici. Clairement, ils étaient mieux préparés. Je pense que les événements nous l'ont montré.

Cependant, je m'intéresse un peu plus au dénouement de la chose. Ici, à Ottawa, on a apparemment eu besoin de la Loi sur les mesures d'urgence pour dénouer le tout, mais ce n'est pas ce qui s'est passé à Québec, parce qu'on n'a pas laissé les manifestants s'installer.

À Windsor, au pont Ambassador, les manifestants se sont installés, mais on a été en mesure de les déloger et de démanteler le blocage sans l'application de la Loi sur les mesures d'urgence.

Je vous repose la question que j'ai posée tout à l'heure. Avant d'avoir recours à la Loi sur les mesures d'urgence, vous aviez levé la main et demandé du renfort pour avoir des agents supplémentaires. Si vous les aviez reçus, pensez-vous que cela aurait pu changer la donne?

**Mr. Steve Bell:** Mr. Chair, as I indicated, the pieces that we needed to come together needed to come together and they ultimately came together that allowed for our dismantling of the operation. Those pieces included the amassing of the resources we required and the tools we needed to create the environment that we could undertake the operation to ultimately dismantle. Those are the timelines that we've identified and those are the timelines that I've spoken about over the course of these questions.

Mme Kristina Michaud: J'ai l'impression que ces outils et ces ressources étaient déjà à votre disposition et que ce n'est pas la Loi sur les mesures d'urgence qui a permis de les utiliser.

Quand une voiture obstrue la voie publique, on peut donner une contravention, on peut la faire remorquer, on peut ériger des barrières physiques, on peut bloquer des rues. Bref, on peut empêcher des voitures de s'installer. Ce sont tous des pouvoirs que vous aviez déjà. Pourquoi ne les avez-vous pas utilisés avant?

J'ai l'impression qu'il y a eu un changement de mentalité une fois que la Loi a été décrétée. Auparavant, on voyait les agents qui encadraient, qui surveillaient la manifestation, comme si c'était une manifestation normale alors que ce ne l'était clairement pas, car c'était une occupation.

Avant cela, on n'avait pas vu d'agents qui essayaient de déloger les manifestants. Pourquoi n'a-t-on pas essayé de les déloger avant, même s'il y avait peut-être un petit manque de ressources? Les outils étaient clairement déjà à votre disposition.

Mr. Steve Bell: The Emergency Measures Act—

**The Chair:** Sorry, we're out of time, but I'm going to give you 10 seconds to answer that please.

Mr. Steve Bell: The Emergencies Measures Act specifically provides us authorities to utilize those officers who attended. It specifically provided us authorities to exclude vehicle and pedestrians from the area, authorities we did not have prior to it being evoked.

The Chair: Thank you very much.

Mr. MacGregor, over to you for two and a half minutes. All yours.

Mr. Alistair MacGregor: Thank you, Chair.

Chief Bell, the Integrated Terrorism Assessment Centre in the week before the convoy arrived in Ottawa provided intelligence assessments that concluded that violent extremist groups were deeply involved in the protest movement. Then we have a convoy with that assessment arriving in our nation's capital, setting up on Wellington Street right beside the Prime Minister's Office, right beside the seat of our democracy, how did those assessments inform police behaviour? That should have put you on high alert. Even if what turned out afterwards was far from the assessment, that assessment alone should have put your police officers on high alert that something potentially could happen in a very bad way.

**Mr. Steve Bell:** What I can say is we were on high alert as an organization, and we thank our partners from the OPP and the RCMP who helped us actively gather intelligence throughout the build up to this and ultimately all the way throughout the occupation and ultimate takedown.

We are actively now engaged in the reviews that identify what was the information we had, what were the courses that were taken and how can we learn in order to be able to make sure something like this does not occur again.

What I can tell you is the planning that we had done was exactly in line with protest planning that had been done in the past, what we saw [Inaudible] in front of us was an extremely unprecedented [Inaudible] occupation.

**Mr. Alistair MacGregor:** At the time, though, did you feel that was a national security threat? When you received those assessments, did your police officers feel that was a viable national security threat?

**Mr. Steve Bell:** As the intelligence experts who we have with us, I am actually going to turn this question over to Commissioner Carrique, to identify as he and his organization were principal in gathering that intelligence.

Commissioner Carrique.

Commr Thomas Carrique: Thank you, Chief Bell.

Through you, Mr. Chair, we did identify it as a threat to national security through the provincial operations intelligence bureau on or about February 7.

Mr. Alistair MacGregor: Thank you.

The Chair: Thank you very much.

Colleagues, we have two more questioners, but not sufficient time to give them the full allotment.

I'm going to ask Mr. Shipley and Mr. McKinnon to confine their periods to three minutes each.

Mr. Shipley, the floor is yours for three minutes.

Mr. Doug Shipley: Thank you, Chair.

Very quickly to both Commissioner Carrique and to Interim Chief Bell, were you at any time during this protest given any political direction from any level of government, be it your counsellor, your mayor, your board of police or your provincial or federal jurisdictions?

Commr Thomas Carrique: I can answer first, Mr. Chair.

Absolutely not. At no point in time did I receive any direction.

I am solely responsible for the operations of the Ontario Provincial Police.

Mr. Steve Bell: I can concur with Commissioner Carrique.

I must make the statement, though, that I did not become chief of this operation until February 15, and from that time, moving forward, I have received no political direction or intonation around what I should do. We operate as an independent policing service under the oversight of our police services board.

Mr. Doug Shipley: Thank you for that, and that's reassuring to know.

Interim Chief Bell, it was a bad situation, quite frankly. When I am here I live in downtown Ottawa. I walked through this protest, coming to work in the morning and at night.

I was surprised, though. There was one particular night when I walked home with a colleague and I'll admit, we took a little bit of a longer route to just keep an eye and see what was going on to have a look at this, as I had to walk through it. That night—and it was probably about nine o'clock at night or so—I did not see one single Ottawa police officer anywhere in the protest, keeping an eye on anything.

I have heard that perhaps absences were up at the beginning of this protest. Could you maybe give me some information as to why there wouldn't be any officers there, and if absences were up at the beginning of this protest?

**Mr. Steve Bell:** Mr. Chair, I can't comment specifically on what was observed because I'm unsure of the exact date and time.

What I can tell you is that our members, members from across the country came together in force to actually help support the take-down of the occupation. It took a considerable amount of time to amass that number of resources and in the early days of the illegal occupation, we indicated the resourcing pressures that we felt, as an organization.

We relied on the Ontario Provincial Police, the Royal Canadian Mounted Police to help support our operations.

Although I can't comment on whether you saw an Ottawa police member in the crowd or not, what I can tell you is that from the time that this started to ultimately the time it was taken down, police members monitored and actively worked to dismantle it.

Mr. Doug Shipley: Thank you for that answer.

I should have clarified that I didn't see any uniform members. I'm sure there were other members in and about there.

My last question is, then—

The Chair: You have 10 seconds, sir.

**Mr. Doug Shipley:** Very quickly, I know that Chief Sloly kept requesting the number of 1,800 officers. Was there a plan to use those 1,800 officers?

**The Chair:** That will have to be a yes or no answer.

**Mr. Steve Bell:** Absolutely. The number 1,800 was built around a plan that ultimately we needed to build to monitor, maintain, stabilize and ultimately dismantle. That's what we were ultimately able to amass as the refined planning went into—

The Chair: Thank you very much.

Now, for our last three-minute slot I understand that I go to Mr. Zuberi.

Mr. Sameer Zuberi (Pierrefonds—Dollard, Lib.): Thank you, Mr. Chair.

I'd like to thank all the witnesses for being here and for doing your duty to protect and serve society.

I'd like to double-back on some remarks that have been made thus far. We heard from the OPP, Interim Chief Bell, that on February 7 you had intelligence saying that there was a national security threat.

Was this national security threat related to far-right extremism?

I'm not sure if you can hear me.

I ask that my time be paused while we're waiting for the answer.

**The Chair:** Chief, did you hear the question? Are you there?

**Mr. Steve Bell:** I'm sorry, my mistake. I had believed that question was for Commissioner Carrique, around the intelligence. My apologies.

Mr. Sameer Zuberi: No, for the Ottawa....

**Mr. Steve Bell:** So, again, I will defer to Commissioner Carrique around the intelligence. It was the OPP who led the intelligence efforts around this.

Mr. Sameer Zuberi: If you could reply quickly, was that related to far-right extremism?

**Commr Thomas Carrique:** Sorry, Mr. Chair, this is not the appropriate venue to get into the specifics of intelligence.

What I can tell you is that the collection of intelligence, right across this country, with the simultaneous activities going on and the events in our nation's capital, we did identify—collectively—a risk to national security.

Mr. Sameer Zuberi: Thank you for confirming that.

We've spent about a minute or so of lost time due to lack of answers, so I ask for that back.

Going back to the OPP.... There was a real and live national security concern. You've said that Ottawa handles hundreds of protests every year. Were you in contact with the protest organizers in advance of the actual protest or convoy? If so, did you try to prevent them from entering Wellington Street and the Parliamentary precinct?

Mr. Steve Bell: I believe that question is for me as I'm the one who stated we have managed hundreds of protests.

We regularly, and in all occasions, attempt to make contact and liaise with the organizers. That's the important part of our police liaison team. [Inaudible] extremely successful—

Mr. Sameer Zuberi: I'm sorry, I'm just trying to ask a question.

Were you successful in making contact with the protest organizers?

**Mr. Steve Bell:** This was a difficult group to identify protest organizers within. It was a fractured, frayed group. We did make contact with several people—

Mr. Sameer Zuberi: Thank you. My time is very limited.

I found the Facebook page of the convoy was developed as of January 14. The protests started on January 22. Were you in contact with the protest organizers through information they made available through their Facebook page and other methods?

Mr. Steve Bell: So, again, the protest organizers were extremely difficult to identify because it was a very fractured, frayed group of people. Our police liaison team members did an amazing job in contacting as many different people that had identified themselves as organizers to start discussions.

The Chair: Okay, thank you very much. I added it to the time—

Mr. Alistair MacGregor: I have a point of order, Chair.

Just quickly, I was wondering through you, if you could invite our witnesses to provide written briefs. They may not have been able to fully develop some of their answers during testimony and I think written briefs, from both departments, would aid our committee in getting a fulsome picture of this.

The Chair: Sure, I can make that request.

I want to thank the witnesses for coming to appear in front of this committee at a very difficult time. The request has been made that—

Mr. Ron McKinnon (Coquitlam—Port Coquitlam, Lib.): I have a point of order, Mr. Chair.

Sorry to interrupt. During the course of this meeting, Mr. Lloyd has tweeted that "Ottawa interim chief Bell confirms that no firearms were found during a clearing of the convoy protests." That's not the testimony I heard. I believe that mischaracterizes Chief Bell's testimony, and I would urge people to look at the actual testimony.

The Chair: We're not going to be debating tweets in front of the committee, however I will ask the witnesses to

feel free to give us more information if they had insufficient time to answer these questions fully. I would encourage them to do that.

On behalf of the committee, in fact, on behalf of the Parliament of Canada, I want to thank witnesses. I know how intense a time this has been for all of you. We appreciate you sharing your views and your perspectives for us. Thank you very much.
